

## SOLAR SHADE SCREEN REBATE APPLICATION

Please Note: The ED3 Rebate program is subject to availability of funding and the program is subject to change without notice. Due to the limits on funds applications are processed on a first-come, first-served basis.

## **Terms & Conditions:**

- 1. Application must be submitted by ED3 primary account holder.
- 2. Installation and purchase must be completed within the current calendar year and application submitted within 60 days of purchase.
- 3. Rebate amount of \$0.80 per square foot of professionally installed shade screens may not exceed the cost of the shades.
- 4. Limit \$250 in rebates per residence for solar shades.
- 5. Only new, not used or refurbished, solar shade screens installed on sunstruck windows (east, west and south exposed windows) qualify for rebate. The material of the solar shade must block at least 80% of the solar heat gain.
- 6. The screens must be installed on the exterior of clear glass windows that enclose an air-conditioned space.
- 7. Motorized and retractable shade structures are not eligible for the rebate.
- 8. Customer must provide:
  - o Copy of a PAID IN FULL receipt that details:
    - -The installing contractor/company name, address, and Arizona Registrar of Contractors (AROC) license number.
    - -The date of installation.
    - -The address of installation, including unit/apartment number.
    - -The total square footage of installed shade screens listed by direction (square footage on east, south and west listed individually).
    - -The number of screens installed.
    - -The type of windows installed on (Double or Single-Pane)
    - -The percentage of solar heat gain that the shade screen blocks (minimum of 80%).
    - -The total cost of installation (price of north-facing windows and/or bug screen installation).
- 9. Solar shade screens must be installed by a contractor licensed to install shade screens by the Arizona Registrar of Contractors (AROC).
- 10. Allow ED3 to inspect installations, upon request, to verify compliance with all rebate requirements.
- 11. Failure to provide all required documents will result in the return of the application.
- 12. If approved, rebate amount will be applied to your ED3 account as a credit within 1-2 billing cycles. Customers will receive an email advising them of application status.
- 13. ED3 may change and/or cancel the program at any time. In the event of a change, any preapproved applications will be processed and completed under the terms and conditions in effect at the time of pre approval, provided funding for the program is still available.
- 14. ED3 does not endorse any particular product, manufacturer, or contractor as a part of this program.
- 15. ED3 disclaims any, and all liability, loss, or damage that may arise as a result of participation in this program. All purchases are at the discretion of the customer.
- 16. By submitting this application, customer agrees to the listed terms and conditions and certify the documentation provided is true and accurate.
